

etfSA.co.za - SOUTH AFRICAN EXCHANGE TRADED PRODUCT (ETP) AND INDEX TRACKING UNIT TRUST – MONTHLY PERFORMANCE SURVEY

The latest Monthly Performance Survey, for the month of December 2023, is attached.

This presents a good opportunity to review the annual returns of the more than 250 index tracking Exchange Traded Products (ETPs) and index based unit trusts for 2023.

With the MSCI World Indices (ZAR) producing a total return of 30,87% (with dividends reinvested), for the past year, not surprisingly foreign referenced tracker products have dominated the top performing tables for this period.

Notably standing out are the funds that track the high tech indices, particularly in the US. Included here are S&P 500 and Nasdaq 100 tracker funds, with the S&P Info Tech 500 ETF providing a total return of 69,64% for the year.

Also of interest are the specialised ETN tracker funds issued by the Union Bank of Switzerland, that single out specific indices, such as the Solactive Robotics & Drones (UBROBO), Solactive Fintech 20 (UBTECU) and the UBS Metaverse (METVRS). These have produced returns well above the MSCI World Index for the past 12 months, which indicates that the global interest in high tech securities goes further than the "Magnificent Seven".

The South African market has not been completely left behind. Although the FTSE JSE All Share Index only provided a total return of 8,44% (with dividends reinvested) over the past year, some specialised ETFs, such as the Satrix Quality ETF and the Satrix Value ETFs, which seek out specific factor characteristics, have provided strong alpha returns. Also performing well during the past 6 to 12 months, were ETPs and unit trusts tracking SA listed property indices. This might involve an element of catch-up from the very oversold situation for major property sectors in late-2022, so it will be interesting to see if this trend continues in 2024. Lower interest rates might assist in a further recovery in SA listed property indices.

The SA banking sector has also had a good year with the Satrix FINI 15 ETF producing a total return of 18,84% for 2023.

SUMMARY

The Survey measures total investment returns for all 209 JSE listed ETFs/ETNs/AMCs, and 31 index tracking unit trusts for periods of three month to ten years. The summary table of the best performing passive index tracking products is shown on page 2. The total return performance of each Domestic Exchange Traded Fund is shown on pages 3-5; Foreign Exchange Traded Funds on pages 6-8; Commodity ETFs & ETNs on pages 8-9; Index Tracking ETNs on pages 9-11; Actively Managed Certificates (AMCs) on pages 12-14; and Index Tracking Unit Trusts on pages 15-16.
