SEPTEMBER 2022 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST INDEX TRACKING PERFORMANCE SURVEY

The Monthly Index Tracking Performance Survey for the period ended 30 September 2022, is attached.

The rand's sharp depreciation in recent months, against the US dollar, has helped boost investment performance numbers for many foreign referenced ETFs listed on the JSE.

Whilst global equity markets continue to show poor returns and high volatility, single "currency type" ETFs, such as the **NewWave US Dollar ETN**, provide pure rand hedge exposure by linking returns to short-term US deposit interest rates and are not impacted by the turmoil in equity or bond markets. ETFs with linkages to longer-dated US Treasury and other global bonds, are also starting to deliver positive total investment returns, suggesting that this asset class, particularly in rand terms, is now worth considering by investors.

Amongst the best short-term investment returns have been posted by ETFs tracking palladium metal prices, possibly indicating that the commodity price cycle may have further to run, particularly for industrial metals.
