



MARCH 2021 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST INDEX TRACKING PERFORMANCE SURVEY

The Monthly Index Tracking Performance Survey for the period ended 31 March 2021, is attached.

Long-Term

The investment returns for 1 to 10 years are dominated by rand hedge foreign referenced ETFs. These products, facilitated by the inward investment foreign exchange regulations, allow private and corporate investors to access global assets on the JSE without impacting on their foreign exchange allowances. The high investment returns earned from many such ETFs over the past decade, have widely rewarded investors who have diversified into global assets with the convenience of a JSE listing.

The Invest Rhodium ETF continues to show its “super ETF” prowess, as it is the top performing local ETF for periods of 6 months to 5 years.

Short-Term

The market crash after the outbreak of the COVID-19 pandemic in March 2020, has distorted investment returns for the 1 year period. The FTSE/JSE All Share and Top 40 indices have risen by some 54% between March 2020 and March 2021, so local ETFs benchmarking these indices, have delivered stellar returns.

Even allowing for the distortions caused by the market drop 12 months ago, it is becoming clear that the South African equity market is now providing investment returns for periods of 1 year or less that outperform global assets. This could prove to be a cyclical trend and will be watched with interest.
