

Fund information update at 30 September 2023

What is the fund's objective?

The investment objective of the 1invest MSCI World Socially Responsible Investment Index Feeder ETF is to track the MSCI World SRI Select Reduced Fossil Fuel Index ("the Index") as closely as possible, in South African Rand.

What does the fund invest in?

The fund is a feeder fund and as such 1invest will replicate the index by investing in the iShares MSCI World SRI UCITS ETF. This underlying fund tracks the performance of the MSCI World SRI Select Reduced Fossil Fuel Index ("the Index") and aims to replicate the performance of the Index.

The Index includes large and mid-cap securities across 23 Developed Market countries. It aims to represent the performance of companies that are consistent with specific values and climate change-based criteria, and those that exhibit a high minimum level of ESG performance. The fund actively excludes companies in industries related to Controversial Weapons, Nuclear Weapons, Tobacco, Civilian Firearms, Conventional Weapons, Alcohol, Gambling, Adult Entertainment, Nuclear Power, Genetically Modified Organisms, Thermal Coal, Oil Sands, Oil & Gas, Power Generation and Thermal Coal/Oil Sands Reserve.

The fund may also hold a small portion in cash instruments to effect efficient portfolio management.

What possible risks are associated with this fund?

Risks include general market conditions and market volatility, company specific risk, country specific risk, exchange rate risk, economic and political risk.

Total Expense (TER): This ratio shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated over the period shown and annualised to the most recently completed quarter. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER should not be regarded as an indication of future TERs.

Transaction Costs (TC): This ratio shows the percentage of the value of the fund incurred as costs relating to the buying and selling of the fund's underlying assets. TC are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER.

Total Investment Charges (TIC): This ratio is simply the sum of the TER and TC, showing the percentage of the value of the fund incurred as costs relating to the investment of the fund. It should be noted that performance figures account for all costs included in the TIC ratio, so you should not deduct the TIC from performance figures, the performance is already net of the TIC.

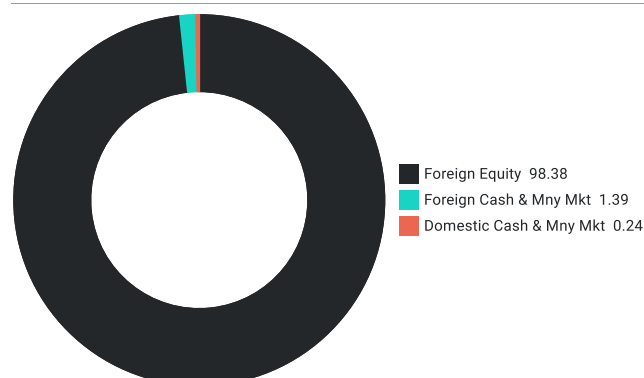

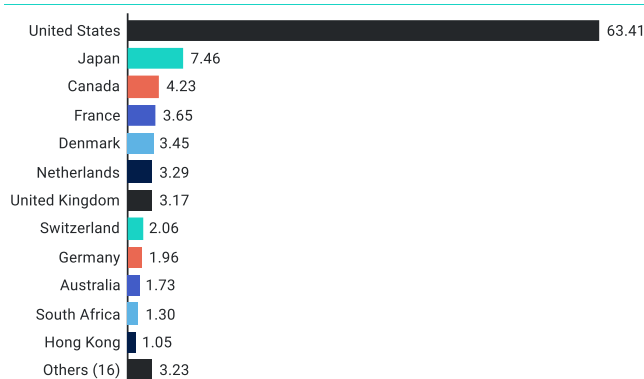

Commentary

Fund review

The fund provides diversified exposure to large and mid-cap securities with exceptional Environmental, Social and Governance (ESG) ratings across 23 developed countries. The top five country exposure was allocated per The United States (64%), Japan (7%), Canada (4%), France (4%) and Denmark (3%) as at end of Q3 2023. The top five equity holdings are Tesla Inc (5%), Microsoft Corp (4%), Home Depot Inc (3%), Novo Nordisk Class B (2%) and ASML Holdings NV (2%) out of 415 equity holdings. The fund's weighted average dollar dividend yield is 2.16% as at end of Q3 2023.

Market overview

For most of the year, global central banks have maintained restrictive monetary policy and interest rates have reached unsustainable levels. This has pushed equity markets lower. In Q3, the MSCI World Index declined by -3.8%, the MSCI EMEA by -2.7% and the MSCI EM by -3.7%. In the US, the Federal Reserve increased rates by a quarter-point in July, adjusting the short-term benchmark that impacts yields on various securities, including the 10-year Treasury. However, in the September meeting, the Fed decided to maintain its benchmark interest rate at a range of 5.25% to 5.5%, indicating that there could still be more rate hikes in 2023. The US economy was also projected to grow at a 5.8% annualised rate in the third quarter, as per the Atlanta Federal Reserve's GDPNow forecast model. Locally, the MPC decided to maintain the repo rate at 8.25% at the September meeting, showing a cautious stance amidst the current economic challenges. Load shedding in SA was a feature for most of Q3, sometimes spiking to stage 6. Rising oil prices resulted in consecutive fuel price hikes, adding to the pressure on inflation. High interest rates were negative for domestic equity markets but benefited the fixed income markets. In Q3, the Top 40 Index dropped by -4.62%, the All-Share Index by -3.48% and the FTSE/JSE Capped SWIX by -3.81%. The All-Bond Index returned 2.06% while the STeFI gained 1.38%.

Looking ahead

Global market expectations have generally shifted from a recession to a soft landing. Although the US FOMC kept interest rates unchanged in its September meeting, suggesting rates have reached a preliminary peak, there is lingering uncertainty about future moves, which will influence economic performance. While a buoyant labour market (with August job openings of 9.6 million beating the consensus estimates of 8.8 million) will support the economy in Q4, and is likely to push inflation higher, fiscal instability remains a key risk after the removal of Republican Kevin MacCarthy as the US Speaker of the House in a vote of no confidence. The US debt-ceiling is another risk, as the 45-day funding bill represents only a short-term fix, as the government still faces a shutdown if Congress fails to extend funding by 17 November 2023. Locally, the interest rate hiking cycle seems also to have also reached a preliminary peak, but inflation remains a concern. At 4.8%, inflation remains within the SARB's 3%-6% target range. The SARB has kept the repo rate unchanged at 8.25%, noting that whether inflation remains within the target band will be the most important factor on the timing of a shift towards less restrictive monetary policy. Rising fuel prices further represent a risk to domestic inflation, with October's hikes at R1.08 and R1.14 per litre for 93 and 95 unleaded petrol, respectively. This is mainly due to the strengthening of global oil prices, as Brent crude breached the \$90/barrel mark for the first time in almost a year. Towards the end of Q3, Eskom implemented lower levels of load shedding after the reopening of unit 3 of Kusile Power Station two months ahead of schedule. If lower levels of load shedding are maintained, it will support business activity and improve business sentiment. The outbreak of bird flu at an unprecedented level presents a major risk for producers of poultry and complementary products, with a number of major retailers being affected.
