

## **MARCH 2022 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST INDEX TRACKING PERFORMANCE SURVEY**

The Monthly Index Tracking Performance Survey for the period ended 31 March 2022, is attached.

### **3-10 Years**

Foreign referenced ETFs continue to dominate the medium to long-term investment returns for the top performing investment tracking products. This has, of course, been the combination of good global equity market returns and the depreciation of the rand exchange rate over the medium to longer term.

A particular feature has been the performance of commodity backed ETFs, with the **Invest Rhodium ETF** the stand-out performer. The relative scarcity of this mineral, which is used in emissions controls, has contributed to its exceptional investment returns for 3 to 5 years.

### **1-3 Years**

For the 2 and 1 year periods, the pendulum has swung completely with South African referenced ETFs and unit trusts, significantly outperforming global equities. The recovery of the general SA equity markets from the 2016-2020 bear market phase and the latent strength of the rand exchange rate, have been contributing factors.

The best performing index tracking products have been those that provide high income returns, like the Dividend Plus index, Preference shares and other high dividend paying sectors, like financials.

### **3 – 6 Months**

The rise in inflation in the major global economies, caused by the supply shocks associated with COVID-19 and more recently the Russia/Ukraine War, has revived interest in commodities, but with extreme volatility associated with many minerals.

Investors have continued to look for some element of safety and so the higher dividend paying ETFs and unit trusts have held up well during the recent times of uncertainty.
