Fund information update at 31 March 2022

What is the fund's objective?

The objective of the 1invest SA Bond ETF is to track the S&P South Africa Sovereign Bond 1+ Year Index as closely as possible.

What does the fund invest in?

The fund invests in the constituents of the S&P South Africa Sovereign Bond 1+ Year Index and aims to replicate the Index by holding the same weightings of these constituents. The S&P South Africa Sovereign Bond 1+ Year Index seeks to track the performance of local currency denominated sovereign debt publicly issued by the government of South Africa in its domestic market, with maturities of one year or more. The fund is rebalanced monthly and therefore has minimal trading costs. The fund may also hold a small portion in cash instruments and listed derivatives to effect efficient portfolio management.

What possible risks are associated with this fund?

Risks include default risk, interest rate risks, inflation risk, market volatility, economic and political risk.

Total Expense (TER): This ratio shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated over the period shown and annualised to the most recently completed quarter. Transaction Costs (TC): This ratio shows the percentage of the value of the fund incurred as costs relating to the buying and selling of the fund's underlying assets. TC are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER.

Total Investment Charges (TIC): This ratio is simply the sum of the TER and TC, showing the percentage of the value of the fund incurred as costs relating to the investment of the fund. It should be noted that performance figures account for all costs included in the TIC ratio, so you should not deduct the TIC from performance figures, the performance is already net of the TIC.

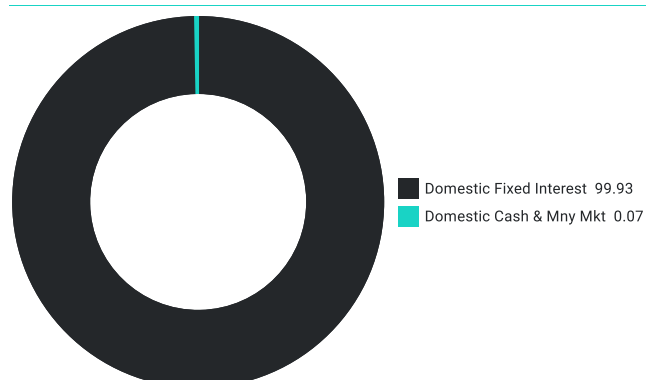

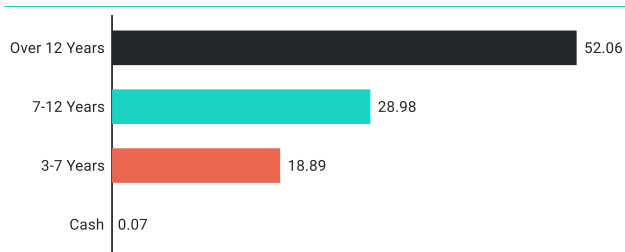
Asset allocation (%)

Commentary

Fund review

The review of the S&P South Africa Sovereign Bond 1+ Year Index (SPFIZAA) in the last quarter saw the deletion of R2023 and no additions to the index. The fund performed in line with the Index. The R186 Government bond remained the largest bond in the fund and its yield increased from 7.84% to 8.13% and its modified duration decreased from 3.89 to 3.64 over the quarter. The fund's yield increased from 9.55% to 9.83% and its modified duration increased from 6.44 to 6.69 over the quarter.

Market overview

Q1 2022 saw Russia's invasion of Ukraine and the resulting sanctions imposed by various countries on Russia. Consequently, commodity prices surged as supply pressures heightened globally for oil and other commodities of which Russia is a net exporter (e.g., Wheat). The global economy slowed, and US inflation reached a 40-year high of 7.9% as at the end of February. Consequently, the Fed hiked rates for the first time in 3 years which sent a further shock throughout markets worldwide. Global markets felt the pressure and were mainly in the red over the quarter with the MSCI World returning -5.04%, MSCI EM at -6.99%, and the MSCI EMEA at -14.43%. Locally, the president relaxed Covid restrictions even further, giving more momentum to the re-opening of the economy. However, the local market was not spared from feeling the effects of the Russian invasion of Ukraine, with surging commodity prices driving the petrol price to unchartered territory. Local indices saw solid gains even when compared to global peers. The resources and industrials rally drove the markets with the Top 40 returning +3.64%, All Share at +4.07%, Capped SWIX ALSI at +6.72%, ALBI at +1.86%, STeFI at +1.03% and the ZAR strengthening 8.32% relative to the USD.

Looking ahead

2021 was a year of recovery. However, 2022 is expected to be a year of moderation, especially when it comes to economic growth. Globally, restrictive monetary policy has taken effect and both the Fed and the MPC are expected to tighten further over the course of the year. As a result of these interventions, we expect economic growth and risky asset classes (e.g., equities) to be adversely affected. Even though the impact of Covid seems to be diminishing in the local market, coupled with the relaxation of restrictions, a fifth wave is still expected by experts. In various global markets, we have seen a recent resurgence in cases, with China introducing new Covid-related restrictions. Given the looming resurgence of Covid risks, the Tourism industry can be expected to be one of the worst hit industries. Other major risks to consider are broader geopolitical tensions, especially the escalating situation between Russia and Ukraine. Should these countries fail to reach a peace agreement soon, the global energy crisis will be exacerbated, with oil and gas already under significant pressure. Broad supply chain pressures can be expected with accompanying cost push inflation.
