## What is the fund's objective?

The objective of the 1invest SA Property ETF is to track the SA Listed Property Index (SAPY), as closely as possible.

## What does the fund invest in?

The fund invests in the constituents of the SA Listed Property Index and aims to replicate the Index by holding the same weightings of these constituents. The SAPY is an Index of the top 20 liquid property companies by market capitalisation that have a primary listing on the JSE. The fund is rebalanced quarterly and therefore has minimal trading costs. The fund may also hold a small portion in cash instruments and listed derivatives to effect efficient portfolio management.

## What possible risks are associated with this fund?

Risks include general market conditions and market volatility, company specific risk, interest rate risk, property value risk, economic and political risk.

**Total Expense (TER):** This ratio shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated over the period shown and annualised to the most recently completed quarter. **Transaction Costs (TC):** This ratio shows the percentage of the value of the fund incurred as costs relating to the buying and selling of the fund's underlying assets. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER.

**Total Investment Charges (TIC):** This ratio is simply the sum of the TER and TC, showing the percentage of the value of the fund incurred as costs relating to the investment of the fund. It should be noted that performance figures account for all costs included in the TIC ratio, so you should not deduct the TIC from performance figures, the performance is already net of the TIC.

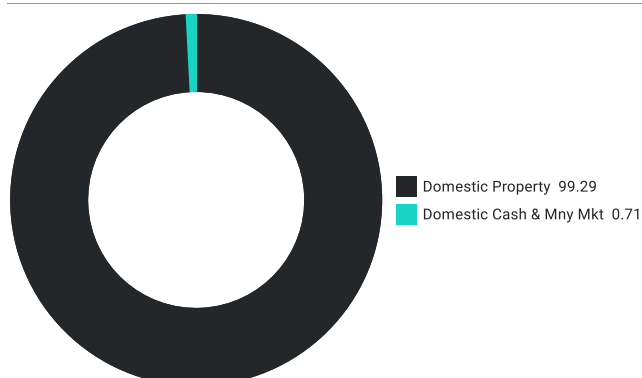

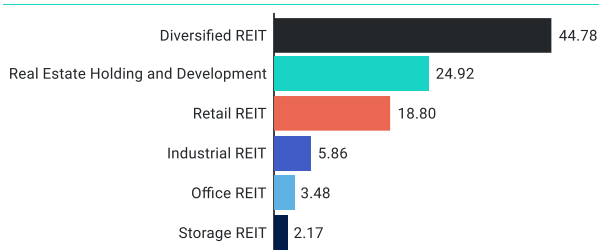
### Asset allocation (%)

## Commentary

### Fund review

The fund has performed in-line with its benchmark over the quarter. The last FTSE/JSE index review saw the deletion of Industrials REIT Ltd and no additions to the index for the quarter. Index performance was strong relative to last quarter, with most stocks showing positive gains. Fortress REIT Ltd B Ord Shs, Vukile Property Fund Ltd and Emira Property Fund were the top three performers, with Fortress REIT Ltd B Ord Shs returning 14.46%. Sirius Real Estate Limited, Industrials REIT Ltd and Liberty Two Degrees Ltd detracted from fund performance, with Sirius Real Estate Limited returning -19.95%.

### Market overview

Q1 2022 saw Russia's invasion of Ukraine and the resulting sanctions imposed by various countries on Russia. Consequently, commodity prices surged as supply pressures heightened globally for oil and other commodities of which Russia is a net exporter (e.g., Wheat). The global economy slowed, and US inflation reached a 40-year high of 7.9% as at the end of February. Consequently, the Fed hiked rates for the first time in 3 years which sent a further shock throughout markets worldwide. Global markets felt the pressure and were mainly in the red over the quarter with the MSCI World returning -5.04%, MSCI EM at -6.99%, and the MSCI EMEA at -14.43%. Locally, the president relaxed Covid restrictions even further, giving more momentum to the re-opening of the economy. However, the local market was not spared from feeling the effects of the Russian invasion of Ukraine, with surging commodity prices driving the petrol price to uncharted territory. Local indices saw solid gains even when compared to global peers. The resources and industrials rally drove the markets with the Top 40 returning +3.64%, All Share at +4.07%, Capped SWIX ALSI at +6.72%, ALBI at +1.86%, STEFI at +1.03% and the ZAR strengthening 8.32% relative to the USD.

### Looking ahead

2021 was a year of recovery. However, 2022 is expected to be a year of moderation, especially when it comes to economic growth. Globally, restrictive monetary policy has taken effect and both the Fed and the MPC are expected to tighten further over the course of the year. As a result of these interventions, we expect economic growth and risky asset classes (e.g., equities) to be adversely affected. Even though the impact of Covid seems to be diminishing in the local market, coupled with the relaxation of restrictions, a fifth wave is still expected by experts. In various global markets, we have seen a recent resurgence in cases, with China introducing new Covid-related restrictions. Given the looming resurgence of Covid risks, the Tourism industry can be expected to be one of the worst hit industries. Other major risks to consider are broader geopolitical tensions, especially the escalating situation between Russia and Ukraine. Should these countries fail to reach a peace agreement soon, the global energy crisis will be exacerbated, with oil and gas already under significant pressure. Broad supply chain pressures can be expected with accompanying cost push inflation.
