## What is the fund's objective?

The objective of the 1invest S&P500 Index Feeder ETF is to track the S&P500 index ("the Index") as closely as possible, in South African Rand.

## What does the fund invest in?

The fund is a feeder fund and as such it invests in the iShares Core S&P500 UCITS ETF. This underlying fund tracks the S&P500 Index and aims to replicate the performance of the Index.

The S&P500 Index gives the performance of the top 500 leading US listed companies and captures approximately 80% coverage of available market capitalisation. The Index is rebalanced quarterly.

The fund may also hold a small portion in cash instruments to effect efficient portfolio management.

## What possible risks are associated with this fund?

Risks include general market conditions and market volatility, company specific risk, country specific risk, exchange rate risk, economic and political risk.

**Total Expense (TER):** This ratio shows the charges, levies and fees relating to the management of the portfolio and is expressed as a percentage of the average net asset value of the portfolio, calculated over the period shown and annualised to the most recently completed quarter. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER should not be regarded as an indication of future TERs.

**Transaction Costs (TC):** This ratio shows the percentage of the value of the fund incurred as costs relating to the buying and selling of the fund's underlying assets. TC are a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, investment decisions of the investment manager and the TER.

**Total Investment Charges (TIC):** This ratio is simply the sum of the TER and TC, showing the percentage of the value of the fund incurred as costs relating to the investment of the fund. It should be noted that performance figures account for all costs included in the TIC ratio, so you should not deduct the TIC from performance figures, the performance is already net of the TIC.

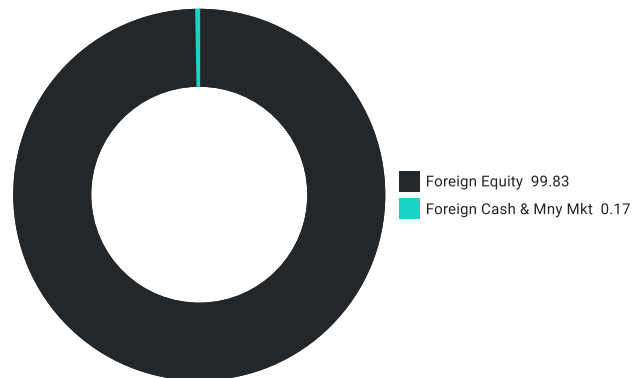

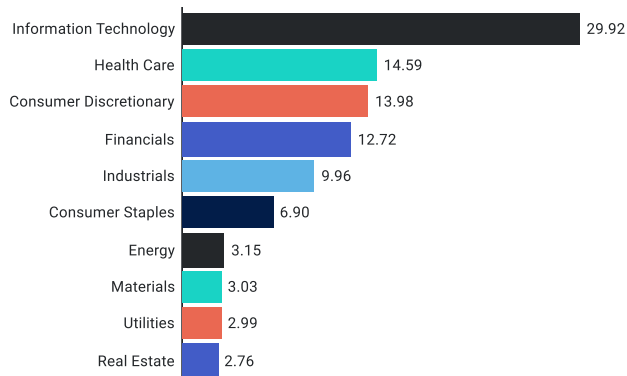

## Commentary

### Fund review

The fund performed in line with the Feeder Fund and the index over the quarter.

### Market overview

Global markets rallied over Q1 2021 on the back of two key themes: greater than expected stimulus in the U.S.; and positive global vaccine development and rollout progress. During this quarter, the MSCI EMEA was up 7.3%, MSCI World was up 4.5% and MSCI EM was up 1.9%. The acceleration of vaccine rollout and other signs of strong economic growth in the U.S. led to a big rise in bond yields, where the U.S. 10-year yield was up 34bps over the quarter to 1.74%. In South Africa, the government added 20 million J&J doses to the 11 million already in the pipeline, resulting in lifted projections for economic growth and a significant boost in confidence. The Monetary Policy Committee kept the repo rate unchanged over the quarter at 3.5% and revised annual GDP growth expectations from 3.6% to 3.8%. The annual rate of inflation eased to 3.1% y/y in December 2020 which was down from 3.2% y/y in November 2020, but up from 3.0% y/y in September 2020. Policymakers indicated that inflation expectations for Q1 2021 have eased and that inflation is expected to be well contained in 2021 before rising to near the midpoint of the inflation target range in 2022 and 2023. Local indices were mostly up over the quarter, including the Top 40 (+13.19%), All Share (+13.14%), the Capped SWIX ALSI (+12.16%), ALBI (-1.70%), and the STeFI (+0.90%).

### Looking ahead

The prospects for a sustained reopening of economies through the second half of 2021 appear promising. The continued rollout of COVID-19 vaccines means that the majority of populations in most developed economies should achieve some level of immunity by early Q3 2021. However, efforts in developing countries have been lacklustre, which will only serve to delay significant economic recoveries in those countries. Policymakers have pledged continued support through accommodative monetary policy that will keep financial conditions supportive of credit demand as the economy recovers from the pandemic and associated lockdowns. In the U.S. all eyes will continue to be on short-term policy decisions and reforms, with a particular focus on U.S. and China trade. The \$1.8 trillion fiscal stimulus (equal to 8.4% of U.S. GDP comes on top of \$900 billion passed late in December 2020) is set to supercharge the U.S. recovery as COVID-19 restrictions are eased. Other countries will benefit from the spill over effects of U.S. fiscal support. Given the extremely high debt burden for both government and companies due to COVID-19, it is likely that an extended period of low interest rates will continue, with the possibility of further QE measures. Locally, there is still much scrutiny upon South Africa and the response of the ruling party to the pandemic. Vaccine rollout has been bolstered by increased supplies of vaccines, which means the economy is likely to begin recovery sooner rather than later. With the recent ratings downgrades by Moody's and Fitch, and the negative outlook for the country, the coming months are crucial in re-building confidence and positive sentiment around the local economy. Efforts to fight corruption are continuing, and this, combined with a successful response to the coming waves of COVID-19, will go a long way in bolstering investor confidence in South Africa.
