INVESTOR PROFILE

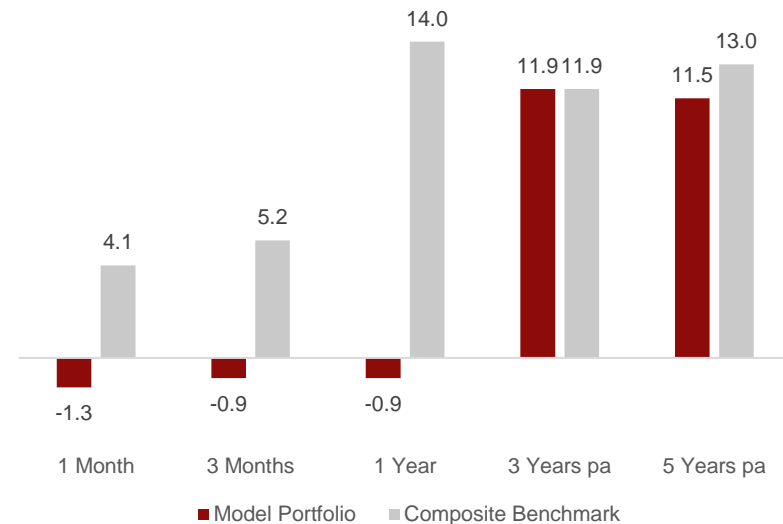

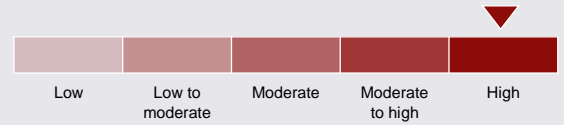

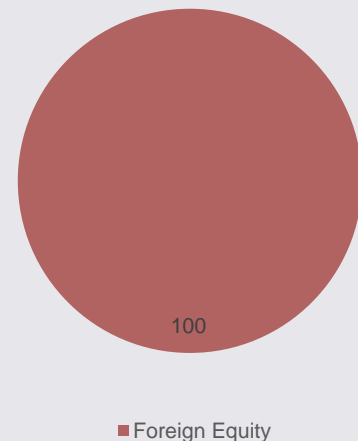
