

MARCH 2019 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST PASSIVE INDEX TRACKING PERFORMANCE SURVEY

The Performance Survey for the period ended 29 March 2019, is attached. The Survey measures total investment returns for all 93 JSE listed ETFs/ETNs, and 39 index tracking unit trusts for periods of one month to ten years. The summary table of the best performing passive index tracking products is shown on page 1. The total return performance of each Domestic Exchange Traded Fund is shown on pages 2-4; Foreign Exchange Traded Funds on pages 5-9; Foreign ETNs on page 6; Commodity ETFs & ETNs on page 7; Currencies on page 8; and Index Tracking Unit Trusts on pages 9-11.

The Performance Survey for the period to end-March 2019, continues to show the dominance of Commodity-backed ETFs and ETNs for periods of 3 months to 5 years.

This masks good investment returns for other asset classes, particularly in the short-term (less than one year). The depreciation of the rand against the US dollar by 25% over the past year, has meant that equity based offshore ETFs have performed strongly. Total returns of over 30% for the past year by many such ETFs are common, with the Global Property ETFs, issued by CoreShares (38,45%) and Sygnia Itrix (37,42%) leading the way.

In the past 3 months, despite the rand showing some stability, the offshore equity based ETFs have continued to perform very well, led by the Stanlib S&P IT ETF (20,63%) and Sygnia Itrix 4th Industrial Revolution ETF (19,11%). The DB China ETN (18,32%) shows that emerging markets are starting to recover.
