

etfSA.co.za - SOUTH AFRICAN EXCHANGE TRADED PRODUCT (ETP) AND INDEX TRACKING UNIT TRUST – MONTHLY PERFORMANCE SURVEY

Long-term

The Monthly Performance Survey for end-December 2022, illustrates the general outperformance of South African referenced equity and bond ETFs, relative to foreign referenced ETPs, for the past 3 years. However, longer-term, helped by an average depreciation of the rand against the US dollar of 7,8% per annum over the past decade, foreign referenced ETPs have delivered the best total investment returns.

The shifting pattern of market returns over the last 10 years, indicates that investors should seek diversification in their investment portfolios because reliance on investing only in offshore assets, can lead to periods of lower returns and heightened volatility, as in the past 3 years. But equally, sole focus on South African listed investment assets, has, in the last decade, resulted in long periods of relative underperformance.

The ETP and index tracking unit trust Survey over the past 10 years, presents a strong case for diversification, not only between local and offshore assets, but also for the use of other asset classes, like bonds, listed property and commodities.

Short-term

The Performance Survey for the periods of up to one year, documents two clear themes.

One is that **commodities**, which was the top performing asset class for most of 2016 to 2021, still has a place in diversified and balanced portfolios.

ETFs and ETNs tracking the price of **platinum** have done well over the past year. The broad themes of clean infrastructure, energy saving and green investment continue to hold sway, even as the pace of growth in the global economy slows. Platinum should be key mineral in the use of fuel cells for generating fossil fuel reduction energy and is an indication that the positive commodity price cycle may still be intact, although the individual commodities that make up the outperformers in the commodity basket could change over time.

Another theme is the quest for **yield**, or **higher coupons**, which is the preferred target for many global asset managers. Specific ETPs that track indices which are based on high dividend yields, have provided superior investment returns over the past year or even longer. Falling into this category have been local resources shares and more recently, listed property ETPs and unit trusts, together with specific indices targeting high dividend yields.

South African equity indices and bonds, offer consistently higher dividend and interest yields than global equities and bonds, so yield sweetening strategies have encouraged investors to refocus on local assets in recent times.
