



FEBRUARY 2022 – etfSA.co.za MONTHLY SOUTH AFRICAN ETF, ETN AND UNIT TRUST INDEX TRACKING PERFORMANCE SURVEY

The Monthly Index Tracking Performance Survey for the period ended 28 February 2022, is attached.

3-10 Years

Foreign referenced ETFs and index tracking unit trusts provide the dominant investment returns over the medium to long-term period, with equity indices being joined by commodity tracking indices in the 3 to 5 year period, as the top investment performers.

1-3 Years

South African referenced tracker funds have been the top performers for the past two years. This includes some smart-beta type indices, tracking factors such as Value and Dividends. A Preference share index tracker issued by CoreShares, the **CoreShares PrefTrax ETF** has also provided market leading returns as risk has multiplied in the markets due to COVID and rising inflation.

3 – 6 Months

In the short term, the recovery in commodity prices, associate with the Russia/Ukraine situation and rising global inflation, is reflected in the recent high investment returns by Oil, Palladium and Rhodium referenced ETFs.

A stand-out local ETF, over the 6 months to 5 year period, has been the **Satrix RESI 10 ETF** which tracks the top ten JSE listed resource companies. This signifies that the positive commodity price cycle has been favourable for some years and still shows signs of continuing.
