etfSA.co.za - SOUTH AFRICAN EXCHANGE TRADED PRODUCT (ETP) AND INDEX TRACKING UNIT TRUST – MONTHLY PERFORMANCE SURVEY

The Performance Survey for the period ended 30 April 2024, is attached.

Foreign referenced ETFs continue to dominate the Survey for period of 1-5 years.

For the shorter term periods measured, i.e. up to one year, the picture is slightly different.

For the **6 months period** ended April 2024, the top investment returns are provided by ETNs that focus specifically on high-tech sectors, like Fintech, Metaverse, Big Data, Space technology, etc.

However, the setback in high-tech in recent months has meant that the best **3-month** returns have been recorded by commodity-based ETFs and ETNs. The **Copper ETN**, issued by Standard Bank, has been the top performer for 3 months, providing a 17,9% total return, followed by silver and gold tracking ETPs. Not surprisingly, the best equity tracker fund has been the **Satrix RESI 10 ETF**, which invests in mining shares and has also been boosted by the corporate action taking place with Anglo American apparently in the sights of global mining companies.

SUMMARY

The Survey measures total investment returns for all 214 JSE listed ETFs/ETNs/AMCs, and 31 index tracking unit trusts for periods of three month to ten years. The summary table of the best performing passive index tracking products is shown on page 2. The total return performance of each Domestic Exchange Traded Fund is shown on pages 3-5; Foreign Exchange Traded Funds on pages 6-8; Commodity ETFs & ETNs on pages 8-9; Index Tracking ETNs on pages 9-11; Actively Managed Certificates (AMCs) on pages 12-14; and Index Tracking Unit Trusts on pages 15-16.
