etfSA.co.za - SOUTH AFRICAN EXCHANGE TRADED PRODUCT (ETP) AND INDEX TRACKING UNIT TRUST – MONTHLY PERFORMANCE SURVEY

January 2024

The latest Monthly Performance Survey for the period ended 31 January 2024, is attached.

For the period of 1 to 5 years, the top index tracking performers have been products that track global indices, with a high exposure to technology companies. The stand out is the **S&P 500 Info Technology Index** trackers, which are available in ETF or unit trust form. The S&P IT index is a benchmark dedicated only to high tech companies, and as such, gives the optimal exposure to this sector, which is becoming a dominant force in the global economic growth, driven by technology innovation.

The S&P 500 and Nasdaq indices also give exposure to high tech companies, but the exposure is diluted by the constituent weighting to other securities, not related to the technology sector. However, for investors seeking diversification, these broader indices are still popular and have performed well.

A growing feature of recent time periods, are the ETNs, issued by UBS, that track stockmarket indices, which outperform similar products issued in ETF form on the same index. An example is the UBS Nasdaq 100 index ETN that delivered a 60,72% investment return over the past year, compared with the Satrix Nasdaq 100 ETF, that delivered a total return of 51,53%. As these products track exactly the same index, the UBS ETN structure is delivered at a lower cost and lower tracking error. The creditworthiness of the issuer bank has to be taken into account by the investor, but there are now a number of examples of ETN trackers being more efficient in delivering investment returns closer to the benchmark index than the same comparative ETF structures.

ETFs and Unit Trusts tracking local listed property indices, have been amongst the best performing index trackers for the periods of 3 months to 12 months. This recovery might be due to some catch up from a heavily oversold position for this sector, but property, as an asset class, is heavily underweighted in the portfolios of most asset managers. Obtaining exposure to the listed property sector, by investing in well diversified portfolios of the larger property securities in the form of ETFs or unit trusts index based portfolios, could be attractive because of the low cost of such tracker funds.

SUMMARY

The Survey measures total investment returns for all 209 JSE listed ETFs/ETNs/AMCs, and 31 index tracking unit trusts for periods of three month to ten years. The summary table of the best performing passive index tracking products is shown on page 2. The total return performance of each Domestic Exchange Traded Fund is shown on pages 3-5; Foreign Exchange Traded Funds on pages 6-8; Commodity ETFs & ETNs on pages 8-9; Index Tracking ETNs on pages 9-11; Actively Managed Certificates (AMCs) on pages 12-14; and Index Tracking Unit Trusts on pages 15-16.
