A feature of the latest Performance Survey of index tracking products in South Africa, is the comeback of SA **listed property ETFs and unit trusts**.

Badly hit by COVID in early-2020 and the virtual shutdown of office usage, shopping facilities and factories that took place at the time, it has taken a long period for this sector of the market to recover.

However, with interest rates likely to fall soon in South African and the return of greater normalcy in local property markets, listed property index trackers, either unit trusts or ETFs issued by Satrix, Sygnia Itrix and 1invest are the top performing funds over 3 months and one year.

The SA listed property index is still 50% below the peaks it reached in 2019, so there should still be further upward momentum in this sector.

Another highlight is the **Satrix FINI ETF**, which tracks the top banks and insurance companies on the FTSE/JSE FINI 15 index. The financial sector has been a key beneficiary of the recent revival in economic activity in South Africa and this sector is particularly well positioned to benefit from the expected recovery in the South African economy over the next few years.
